Information clause for the contractor

- 3. We will process your personal data for the purpose of:
 - fulfilling the legal obligations imposed on the Data Controller by the applicable provisions of law, including those associated with issuing invoices, maintenance of accounting books and tax documentation, (Article 6 (1)(c) of the GDPR in conjunction with the Accounting Act of 29 September 1994, the Act of 29 August 1997 - Tax Ordinance, the Act on tax on goods and services, the Act of 11 March 2004 on tax on goods and services and the Act of 15 February 1992 on corporate income tax),
 - carrying out tender procedures and offering services, therefore the data of persons included in the received documentation will be processed on the basis of the legitimate interest of the Data Controller - Article 6 (1) (f) of the GDPR, i.e. the transfer of data is necessary for conducting a tender procedure or a bidding process,
 - pursuing claims or defending the rights of the Data Controller (Article 6 (1) (f) of the GDPR), which constitutes a legitimate interest,
